# Proposal to be discussed @APNIC 59

- prop-162: WHOIS Privacy
  - This proposal suggests eliminating the unnecessary publication of APNIC member organization contact details (email addresses, telephone numbers, and physical addresses) from any ~~bulk access to~~ Whois data. People with a legitimate need for these contact details can use the Whois search provided by APNIC.
  - v002
    - The proposal has changed scope from Bulk WHOIS to public access WHOIS
    - To obtain addresses, telephone numbers, or email addresses for resource holders this would require to sign up for a free APNIC login, and log into the APNIC/MyAPNIC website



# Proposal to be discussed @APNIC 59

- prop-163: Enhancing WHOIS Transparency and Efficiency Through Referral Server Implementation
  - This proposal refers to the Whois search/server/system/code, and RFC 2167 (Referral WHOIS Protocol Version 1.5) implementing WHOIS Referral Server support.
    - Queries for transferred resources (e.g., ASN or IP addresses) will be automatically redirected to the appropriate RIR database.
    - NIR allocations can be seamlessly queried through a hierarchical system.
    - Downstream allocation information will become accessible, enhancing transparency and traceability.
- The proposal author may be not aware of APNIC's RDAP service, which provides redirection and referrals to other registries.

# NIR CEO round table meeting at APNIC 60

- It was proposed that the APNIC Secretariat organize a Meeting with the NIR CEO/Director General and APNIC Leadership team
- Preferably once a year and at APNIC Standalone conference
- Agenda focuses on high level strategic discussions
